## A Prosecutor with a Heart for Hope Behind Bars



Daniel J. Gabler, Dismas Ministry Board Member

Dismas Ministry is honored to welcome Daniel J. Gabler to our Board of Directors. With over 33 years of legal experience, including his current role as Assistant District Attorney in Washington County, Wisconsin, Daniel brings a deep understanding of the criminal justice system and a profound compassion for those impacted by it. In additional to his current work, he was formerly a criminal prosecutor in the Milwaukee County District Attorney's office for 17 years, the Chairman of the Wisconsin Parole Commission for two years and a Milwaukee County Circuit Court Judge for two years. His varied roles in the criminal justice system drew him to prison ministry because he sees firsthand the sadness, the brokenness, and the need for

deep healing of those who are jailed.

Daniel understands the toll incarceration takes not only on the confined but also on families and communities. His close proximity to this reality fuels his passion for inspiring those in the criminal justice system to move beyond the literal and figurative prison bars, and he strongly believes that Dismas Ministry is part of the solution.

Having worked decades in criminal justice, Daniel recognizes incarceration and supervision has a limited impact in changing lives for the better. "The system wasn't set up to solve all of society's problems.

Unfortunately many view it as a 'silver bullet' to solve messy lives. In reality it's like a rock tumbler.

At times it is uncontrolled and erratic in an effort to smooth out the rough edges of a disordered person."

After years of observations from a front row seat, he shared: "At the core of nearly all crime is the absence of and/or a destruction of the family."

In conjunction with the necessity of the family, Daniel knows that God has to be the foundation of all aspects of living. "Without an embrace of the Triune God, why do we even get up in the morning?" he says. "We must offer people hope through Christ because embracing Christ is really the only way out of the revolving door of recidivism." He notes that there are many times in a courtroom where a person is so steeped in sin, as manifested by their crimes, that all they have left in life is hope because all of their relationships with family and friends have been severed. "Hopelessness leads to despair, and despair leads to giving up. Hope in our loving God is the foundation of a life free of anti-social behavior." *Continued on Page 4*.

## **Expressions of the Soul: A Day to Remember**

On Sunday, April 6, Dismas Ministry hosted *Expressions of the Soul*, a showcase of art created by men and women who are incarcerated. The event was held in cooperation with the Ignatian Volunteer Corps of Milwaukee, of which Dismas is a proud partner agency.

With well over 200 people in attendance, the room was filled with energy, light, and hope - it truly was an emotional event.

The day was about sharing the heart of our brothers and sisters behind bars. We called it *Expressions of the Soul* because their artwork offers a glimpse into their humanity, a side that most people never get to know. Art has a way of creating a space without judgment, a place where beauty and truth can shine through. On April 6, that strength and dignity were on full display.





The event showcased a collection of artwork that has been generously gifted by men and women in custody who have been served by Dismas Ministry over the course of its 25-year history. Each piece tells a story and invites viewers to see the extreme talent, profound resilience, and deep faith that exist even behind prison walls.

Beyond the amazing artwork and the *I Am Beautiful* books, which were very much in demand, the most moving part of the day was the personal encounters. Several guests shared deeply personal stories, many speaking of incarcerated family members. Some came to the event not knowing what to expect but left with resources, encouragement, and a connection to a supportive community. As one mother said, "God led me here today."

One conversation that stood out was with a woman whose son, Jacob, is currently on the run from the law. He has been incarcerated before, and she attended the event carrying a heavy heart. She was assured that Jacob would be kept in prayer, a reminder of how deeply needed the mission of Dismas Ministry is, and how powerful it can be to simply create a space filled with beauty, hope, and grace.

Prior to joining the Board, Daniel worked as a Knight of Columbus (KofC) to bring Christ to the imprisoned. He was inspired by an incarcerated friend who alerted Daniel to the lack of Catholic resources in county jails and state prisons; much of the material is outdated and not relatable. Daniel has since organized a Catholic book drive through KofC Council #4706 to get donated Catholic reading material behind prison walls.

Daniel believes the mission of Dismas Ministry can be a real agent of hope. He encourages supporters to keep their focus on God by helping those behind bars access quality Catholic resources made possible by Dismas Ministry.

We are grateful for Daniel's insights and his steadfast faith in the one Church founded by Christ Himself. We trust and believe it will help strengthen our outreach and bring hope to those who need it most.
